#### JOINTLY DEVELOPED

  as compared to June 2020 by incorporating effective F2F, remote and virtual teaching strategies.
- By June 2022, the percentage of students scoring level 2-4 on the Ga Milestones –ELA (or Universal Screeners scoring at Level 2 or above) will increase by 3% as compared to 2019 by incorporating effective F2F, remote and virtual strategies.
